

# Miyagi Prefecture COVID-19 Quasi-Emergency Measure Requests

▽ The prefecture will be switching to **Quasi-Emergency Measures** (Period : **9/13-9/30** Target areas : **Sendai City**)  
 → These measures will be extended **until September 30**, in accordance with the declared **state of emergency in the prefecture and Sendai City**.

# Request for Prefectural Residents [All Regions of Miyagi]

Refrain from outings, follow thorough prevention measures, etc.

9/13-9/30 (Quasi-Emergency Measures)

【Article 31, Section 6, Paragraph 1/ ; Article 24, Paragraph 9, etc.】

- In order to reduce the number of outings to crowded locations by half, please refrain from non-essential outings during the day. (in particular, do not go to dine-in establishments and other such facilities **without good reason outside of times in accordance with requested early business closures**).
- Refrain from food and drink establishments that do not implement thorough infection prevention measures and do not follow early closure requests (with the exception of delivery/take out).
- Postpone or refrain from **non-essential travel and travel outside the prefecture**, especially to areas under the state of emergency or quasi-emergency measures.
- When conducting necessary outings or travels, travel only in small numbers with family members or friends you interact with regularly if possible. Thoroughly implement basic infection prevention measures such as wearing masks and sanitizing hands. Avoid the 'three Cs' and '5 places' as well as crowded places and times.
- Refrain from group dining or events that involve alcohol with large number of people over extended period of time. . Wear a mask when conversing and be careful even if not drinking alcohol.
- Please comply with infection prevention measures implemented by food and drink establishments.
- Refrain from conducting **high-risk activities** such as drinking alcohol in groups on the sidewalks or in the parks, etc.
- Follow basic infection prevention measures **regardless of whether you have had the vaccine or not**.
- If you feel even slightly unwell, please contact health services and avoid outings as well as contact with others.
