### System Outline

#### Application Period

January 31<sup>st</sup>, 2022 (Monday) through May 31<sup>st</sup>, 2022 (Tuesday)

#### Eligible Beneficiaries

Small and medium-sized corporations and small businesses that satisfy requirements ① and ② may be eligible for benefits.

- ① Businesses affected by COVID-19
- ② Businesses whose sales in any given month between November 2021 through March 2022 (target month) decreased by either 50% or more, or decreased 30% or more but less than 50% when compared to the same given month between November 2018 and March 2021 (base month)

#### Benefit Amount

Small and medium-sized corporations, etc. Up to 2.5 million yen

Small businesses, etc. Up to 500,000 yen

Benefit amount The base period's (see ※1) sales – the applicable month's sales x 5 months' worth

※1 One of the following periods: November 2018 - March 2019 / November 2019 - March 2020 / November 2020 - March 2021 (the period must include the base month)
